Conditions of participation in the emissions reduction programme

The implementation of InnoRecycling AG's «Bring Plastic back» collection system is made possible by contributions from a climate protection programme of the Swiss compensation instrument. Use of the collection bag is subject to acceptance of the following conditions of participation, which apply to all purchasers of the collection bag.

1. General information

By collecting plastic waste separately, households can reduce CO2 emissions. South Pole Suisse AG («SPS») operates a programme to reduce greenhouse gas emissions on behalf of InnoRecycling AG («InnoRecycling»). In return for the certificates issued under the programme, the purchaser benefits from a discount on the plastic collection bag. Receipt of the discount is subject to the following conditions of participation in the programme.

2. Definition

In these conditions of participation, unless the context indicates otherwise, the following terms have the following meanings:

«Purchaser» means the person who buys and uses the collection bag.

«Collection bag» refers to a specially labelled bag for the collection of unmixed plastic waste from households and corresponds to an individual project within the programme. The collection bag has been certified by the Swiss Plastic Recyclers Association (VSPR) since 2020 and guarantees a transparent, environmentally conscious material cycle. This is subject to regular material flow monitoring in accordance with the Empa method.

«InnoRecycling» refers to InnoRecycling AG, based in Eschlikon TG, which distributes collection bags and organises the collection, sorting and recycling of plastic waste.

«Conditions of participation» means this document.

«Discount» means the price reduction on the purchase price of the collection bag for the buyer.

3. Assignment of emission reduction rights

The buyer assigns to InnoRecycling all rights to ownership and entitlement to recognition of the emission reductions achieved in connection with the programme. In particular, the buyer assures InnoRecycling that

- the collection bag does not additionally participate in a national or international emission reduction programme;
- the collection bag is not additionally co-financed by other energy or climate policy support instruments;
- the collection bag is not additionally registered as a project or part of a project bundle for emission reduction in Switzerland;
- the emission reductions achieved with the collection bag are not claimed elsewhere.

4. Use of the collection bag

- The installation, use and delivery of the collection bag is at the expense and responsibility of the purchaser.
- The collection bag may only contain plastic waste from Switzerland whose separate collection is not legally required under the Ordinance on the Prevention and Disposal of Waste (SR 814.600) (e.g. no construction waste).

5. Compensation of the customer

The discount is InnoRecycling's exclusive compensation for the transfer of ownership rights and entitlement to recognition of the emission reductions achieved in connection with the programme. The incentive is passed on by InnoRecycling to the buyer or reseller and is reflected in the purchase price. The buyer is not entitled to a cash payment of the discount. InnoRecycling does not assume any costs incurred by the buyer in connection with the purchase, use and return of the collection bag. If the collection bag is sold, the buyer undertakes to transfer the buyer's obligations contained in these conditions of participation to the new owner, with the obligation to continue to transfer them, and the discount also includes all public-law charges, in particular Swiss VAT

6. Data protection

InnoRecycling is authorised to verify the emission reductions achieved with the collection bag. For this purpose, the buyer grants InnoRecycling access to information required for the monitoring and verification of the emission reductions achieved by the collection bag. This includes the weight, content, origin and composition of the plastic waste contained in the collection bag as well as the time and place of purchase of the collection bag.

InnoRecycling may pass this data on to the programme operator SPS for the purpose of monitoring and verifying the emission reductions. The use or disclosure of the data for other purposes is explicitly excluded.

7. Supplement to the GTC of InnoRecycling

These conditions of participation supplement InnoRecycling's General Terms and Conditions of Contract (GTC). They only apply to purchasers of the discounted collection bags under the programme. If the two documents contradict each other, these conditions of participation shall take precedence.

8. Additions and changes

InnoRecycling reserves the right to modify the conditions of participation at any time if justified by the legitimate interests of InnoRecycling. The buyer must accept changes to the contractual conditions for technical and operational reasons insofar as these are advantageous for the customer or result in a negligible reduction in the compensation services without affecting essential provisions of the contractual relationship. Furthermore, changes that become necessary as a result of legal requirements or court orders are permissible.

9. Place of jurisdiction and applicable law

The contract is subject to Swiss law. All disputes arising from the contract shall be settled by the courts of Zurich. The place of jurisdiction is Zurich 1.

10. Further information

These conditions of participation are available in various languages; only the German version is authoritative for the clarification of questions of interpretation.
